Within the first quarter, you'll be receiving a new debit card with an EMV chip. This will help keep you and your money safe. The new technology is more secure. With the new chip enabled card, we will also be releasing a new mobile app called MobiMoney. MobiMoney will help you keep track of your debit card and debit card purchases. With this interactive mobile app, you will be able to receive transaction and fraud alerts and have ability to set and restrict card usage to specific merchant types, locations, users and threshold amounts. MobiMoney's card controls work for existing debit cards over all existing payment methods. Through the mobile app, you will be able to get transaction alerts, view account balance and transaction history, and much more. Keep an eye out for your new card coming in the first quarter of 2018!
